#### **NEW GAS SUPPLY CONTRACT**

The board of directors (the **Board**) of Yingde Gases Group Company Limited (the **Company**) is pleased to announce that the Company has decided to invest in a production facility in Changshu Economic Development Zone in Jiangsu province in China with a designed oxygen capacity of approximately 18,000 Nm<sup>3</sup>/hr. On 10 November 2009, Yingde Gases Investment Limited, a wholly-owned subsidiary of the Company, entered into a long-term gas supply contract to supply industrial gases to an industrial company located in this development zone and this new customer will utilize a substantial portion of the capacity. The Company is currently expected to complete the construction of the production facility and commence gas supplies before the first quarter of 2011.
